ORGANISATIONAL PROGRAMS

Centre for Evidence-Based Initiatives in Health Care: A JBI Centre of Excellence

JBI is an independent, international, and not-for-profit research and development organisation based at the University of Adelaide, South Australia. JBI promotes and supports evidence-based decisions that drive improved health outcomes in communities globally. JBI offers a range of resources and solutions to access, appraise and apply the best available evidence.

Supported through the provision of clinical and administrative resources by St George Hospital, the Centre

for Evidence-Based Initiatives in Health Care was established by Professor Ritin Fernandez in 2013 and celebrating 10 years in 2023. The centre creates opportunities for clinicians and academics to enhance evidence-based health care through knowledge generation, knowledge transfer and knowledge implementation.

Code Lavender

Code Lavender is a wellbeing strategy designed to improve access to activities beneficial for Nursing and Midwifery staff at St George Hospital. Launched in November 2021, Code Lavender promotes investing time

in staff wellbeing as an integral part of core business. St George Hospital has invested in a dedicated Code Lavender wellbeing room, equipped with comfortable furniture and wellbeing resources. Alternatively, for staff wishing to utilise their own setting, staff can access the Code Lavender trolley for mobile access to resources. With an aim to be responsive to staff needs, bookings can be made in advance or utilise a pager for immediate response. Our Wellbeing Champions have been trained in the facilitation of Code Lavender and are leading the way in the delivery.

Code Lavender is providing a valuable wellbeing resource for staff, with 524 staff members attending a Code Lavender across over 100 sessions in 2022. Not only are staff attending but 97% agree that the session has benefited their wellbeing and that they feel refreshed after. We look forward to what 2023 will bring for Code Lavender and for the staff and their wellbeing.

Productive Ward

The Productive Ward Program at St George Hospital is a nurse led Clinical Improvement program that aims to increase patient, carer and staff safety. In 2021-2022 the teams worked through three modules; Clinical Leadership, Medication Safety and Assessment and Observations.

The Productive Ward leads took on the challenge of creating meaningful and sustainable quality improvement projects with great results. Highlights include a unique 'pop and lock' strategy to encourage staff to lock medication trolleys, a project in Special Care that saves nurses an

estimated 88 hours of time per year and a simple reference tool to help guide nurses to ascertain when patient assessments are due.

Our Productive Ward leads are creative, resourceful and forward thinking in engaging their teams to create solutions to ward-based issues. The collaboration between wards and sharing of ideas has been a highlight and there have been a number of tools shared between wards to enable others to benefit from creative ideas.

We look forward to working through more modules together to create safe and reliable health care.
